EVALUATING THE ANGLOPHONE AFRICA PLATFORM







OVERVIEW

The CS and CGs participating in the Anglophone Africa platform activities conducted a rapid review of the platform to establish what has worked well and future needs of the member to enhance their engagement in GF programs in the region. The objective of the rapid assessment is to measure the usefulness of the platform as well as inform the design and content of the next phase of the platform. Information gathered through the rapid assessment will shade light on critical needs of the CS and CGs in the region and help the platform respond to the identified needs.

The following are the results of the rapid assessment.



RAPID ASSESSMENT RESPONDENTS

A total 42 CS and CGs representatives responded to the rapid assessment. The respondents were drawn from across Anglophone Africa, representing CS and CGs including KP and KAP organisations.

- 5. Organizational capacity building in; 1) organizational development and 2) program design and implementation

- 5. Enhancing the role of CS and CGs in programs sustainability and co-financing of programs by national government
- Documentation and dissemination of best practices, tools, and guidelines to enhance grants performance

MAJORITY OF THE PARTICIPANTS, AT 63%, CONFIRMED TO HAVE ACCESSED TECHNICAL SUPPORT (TS) FROM CRG AND OTHER SOURCES OF TS. IT IS NOTABLE THAT 37% OF THE RESPONDED HAVE NOT ACCESSED TS FOR THEIR WORK.



- 1. Generation and utilization of strategic information. This will include enhancing data collection and analysis as well as development and dissemination of case studies.
- Key population and key affected population programing including effective strategies for KP and KAP interventions
- 3. Community based monitoring
- 4. Domestic resource mobilization and financial sustainability strategies
- 5. Human rights and gender programing
- 6. Organizational development, including governance and leadership
- 7. GF grants design process; FR development, and grant making
- 8. CCM roles and functions
